NO NEED TO PANIC | Centre assures adequate LPG supply, secures additional cargoes

2 LPG vessels clear Hormuz, supply near normal: Govt

Two India-flagged LPG carriers, Green Asia and Green Sanghi, have crossed the Strait of Hormuz and are now headed to India, the Centre said.

Despite long queues at some distribution points, the government maintained that LPG supply remains sufficient. It added that natural gas supply for fertiliser production has been raised to over 90% of pre-West Asia conflict levels.

At an inter-ministerial briefing on the West Asia conflict, Additional Secretary in the Ministry of Shipping Mukesh Mangal said, "The vessels Green Sanghi and Green Asia, carrying LPG, have safely crossed the Strait of Hormuz." He said Green Sanghi was carrying around 46,500 metric tonnes of LPG with 25 Indian seafarers on board, while Green Asia was carrying 15,500 metric tonnes of LPG with 26 seafarers. With this, a total of eight India-flagged vessels have crossed the strait so far.

Following the passage of these vessels, which were stranded in the Persian Gulf due to the conflict involving Iran and the US and Israel, the official said, "There are now 16 India-flagged vessels in the Persian Gulf region, carrying a total of 433 Indian seafarers." He added that Indian maritime operations remain safe and uninterrupted amid the West Asia crisis, and over 964 seafarers have been repatriated from the Gulf region so far.

Meantime, Joint Secretary in the Ministry of Petroleum Sujata Sharma said, "The LPG supply remains sufficient with additional cargoes already tied up to meet demand."

She said state governments are conducting regular reviews to ensure smooth distribution of LPG to domestic and commercial users, for which priority lists have been drawn up. States are also assisting in cracking down on hoarding and black marketing of gas cylinders.

Nine cops get death in TN custodial case

Awarding the rarest of rare punishment in the custodial torture and murder of a father and son in south Tamil Nadu that shook the country during the COVID-19 lockdown, a trial court in Madurai on Monday awarded death penalty to nine policemen found guilty in the case. This is perhaps the first time so many policemen have been sentenced to death in a case of custodial torture, more so in a case where the victim were innocent.

Holding that the policemen who were involved in the faked guilty of the crime, had committed a heinous crime and beaten to death an unarmed husband and son, G. Muthukumar, the First Additional District and Sessions Court Judge, Madurai, said the convicts deserved no mercy. The case according to the judge, fell into the "rarest of rare" realm, and therefore the nine convicts must be hanged till death. The judge also imposed varying penalty amounts on the convicts.

Rarely have trial courts awarded death penalty to all accused in a case. In 1998, a TADA Court near Chennai had awarded the death penalty to all 26 accused in the former Prime Minister Rajiv Gandhi assassination case. However, in 1999 the Supreme Court had eventually reduced the sentences and set free 19 of them and upheld the death penalty only in respect of four convicts and awarded life sentences to three others.

Many years later, the death sentences were commuted by the Supreme Court and all of them walked out of prison.
